## **INTRODUCTION**

The North Carolina Office of State Budget and Management (OSBM) is working with an Advisory Board of state CFOs, Budget Directors, and others to create a certification for state budget professionals.

OSBM identified training and career advancement opportunities for state budget professionals as key to enhancing the work product of budget professionals statewide and increasing retention rates among state budget professionals.

The state budget professional certification Advisory Board met for a series of meetings in the Spring and Summer of 2022 to identify specific skills and knowledge that should be developed during a certification process. The result of these discussions is this application.

The application seeks proposals for delivery of an in-person and/or online curriculum that will provide current and aspiring budget professionals the foundational skills and knowledge necessary to succeed as a state budget professional.

Foundational skills and knowledge identified by the Advisory Board include:

- State Budget Administration and Law for Operating Budgets
- State Budget Administration and Law for Capital Budgets
- Budget Strategy and Analytical Thinking (Including Revenue and Expenditure Analysis)
- Communicating about the Budget
- Data Analytics
- Performance Management, Program Evaluation, and Strategic Planning
- Accounting for Budget Professionals
- Purchasing and Contracting, including Performance Contracting

The questions in this application are designed to provide your institution an opportunity to outline current courses being offered that relate to the aforementioned skills and knowledge and discuss how you would partner with the State to develop new courses in these areas. The questions are broad and open-ended in nature so that your institution may have the flexibility to describe a program that provides a strong learning opportunity for students and is economically sustainable for your institution.

Similar programs in <u>Georgia</u> and at the <u>local level in North Carolina</u> take, on average, two-years to complete and conclude with a series of exams that must be passed for certification. Proposals do not necessarily need to be consistent with these examples, but the examples may serve as helpful reference points.

Through the application, the Advisory Board would also like to encourage collaboration between four-year colleges/universities and community colleges to leverage expertise at North Carolina's many institutions of higher education. OSBM will host a networking event shortly after release of the application for any interested potential providers. This will be an opportunity for OSBM to share about information and for potential providers to identify possible opportunities for collaboration.

The tentative program timeline would allow for the first courses to be offered in Fall 2023 with courses being added until the full list of course offerings is available in Fall 2025.

- d. Goal is to matriculate a minimum of 20 people through the program a year
- e. No expectations about sequence of courses, other than a course covering state budget administration and law coming first
- f. Plan to work once a year with the advisory board and college/university partner to compare the curriculum to current state needs
