## MEMORANDUM

SUBJECT: Deviation Requests from the Department of Military and Veterans Affairs

Pursuant to G.S. 143C-6-4 (b1), prior consultation with Governmental Operations is required when the over expenditure would cause a department's total requirements for a fund to exceed the department's certified budget for a fiscal year for that fund by more than three percent (3%) prior to authorizing the over expenditures.

The Department of Military and Veterans Affairs (DMVA) is requesting to deviate in its Special Revenue -Department of Military and Veterans Affairs (budget code 23050) to close the 2023-24 fiscal year. The deviation request is outlined below.

The Department of Military and Veterans Affairs (DMVA) administers the Scholarship Program for Children of Wartime Veterans. Funds are budgeted in Budget Code 23050, Budget Fund 208905. DMVA is requesting a deviation due to an over-expenditure in their Escheats-Scholarship-Pub Sch Account [56K00004]. The over-expenditure in the Escheats account is a result of disbursements of scholarship funds to public institutions within the UNC and Community College Systems during FY2023-24 for "worthy and needy" students. There is currently an over-expenditure of \$696,636.87 in the Escheats account. DMVA would like to budget available fund balance to cover the overage.
