SUBJECT: Deviation Requests from the NC Department of Insurance

Pursuant to G.S. 143C-6-4 (b1) prior consultation with Governmental Operations is required when the over expenditure would cause a department's total requirements for a fund to exceed the department's certified budget for a fiscal year for that fund by more than three percent (3%) prior to authorizing the over expenditures.

The Department of Insurance (DOI) is requesting to deviate in its Insurance-Trust-Internal Service (budget code 63903) in order budget receipts and an associated over expenditure for a legal settlement that has been paid.

The deviation request is outlined below:

- **Budget Code 63903** – Request to utilize over-realized receipts to budget for over expenditures in account 52919000 in the amount of \$2,000,000. This request is to budget \$2,000,000 received from Ambridge (excess liability insurer) pursuant to a legal settlement (Love vs Town of Kill Devil Hills) to be paid to plaintiffs.

The Department of Insurance submitted budget revision 12-0003 in budget code 63903 to budget a legal settlement. This budget revision was submitted per General Statute, G.S. 58-31-10 (a) (b); G.S. 143C-6-4 (b1), that requires agencies to submit a budget revision to alleviate any deviations exceeding the certified budget for a fiscal year.
