SUBJECT: Required Quarterly Report on State Capital and Infrastructure Fund (SCIF) Grants

Per S.L. 2023-134, section 40.7, the Office of State Budget and Management (OSBM) is required to report to the Fiscal Research Division quarterly on the schedule and status of grant disbursement for State Capital and Infrastructure Fund (SCIF) grants to non-state entities, including the following for each grant:

- a. The date which the disbursing agency issued the initial contact.
- b. The date when the contract was sent to the grantee non-State entity.
- c. The date when the fully executed contract was returned to the disbursing agency.
- d. The date when the contract was executed.
- e. The date when a grant was disbursed in full.

Please see the attached spreadsheet outlining answers to these questions for each grantee for the quarter ending June 30, 2024. In summary, OSBM reached out to all 50 grantees to request the statutorily required documents they have to submit prior to the disbursement of their grant funds. Of the 50 grants, OSBM has administered 39. There are 11 grantees for whom we are waiting on one (or more) of the five legislatively required documents - W-9; electronic payment form; conflict of interest policy; sworn statement re: no overdue tax debts; and a scope of work outlining how their grant funds will be used.

The OSBM Grant Team currently consists of a Grant Manager and four Grant Administrators.

OSBM received more than 1,000 additional grants to administer in the 2023 Joint Conference report and during the past quarter, our office has been working tirelessly to manage the 1,770 current grants administered by our office.

In addition to disbursing new grant funds, the five-person Grants Team at the Office of State Budget and Management continues to provide technical assistance related to reporting, monitoring, and auditing for directed grant recipients. We have continued to hold webinar training courses and Q&A sessions with a recent average attendance of 40 individuals for each of the training webinars. With the addition of more than 1,000 grants in the last budget, we are in need of additional resources and positions to ensure that we can meet our responsibility to be good stewards of these state tax dollars and provide excellent customer service to these grantees.
